Mrs. Anita Jhunjhunwala, age around 34 years, is a graduate in the field of commerce. She has experience in the fields of accounts, finance and administration.

Section 149 of the Act inter alia stipulates the criteria of independence should a company propose to appoint an independent director on its Board. As per the said Section 149, an independent director can hold office for a term up to 5 (five) consecutive years on the Board of a company and he shall not be included in the total number of directors for retirement by rotation.

The Company has received a declaration from Mrs. Anita Jhunjhunwala that she meets with the criteria of independence as prescribed both under sub-section (6) of Section 149 of the Act and under Clause 49 of the Listing Agreement. Mrs. Anita Jhunjhunwala possesses appropriate skills, experience and knowledge, inter alia, in the field of finance.

In the opinion of the Board, Mrs. Anita Jhunjhunwala fulfills the conditions for her appointment as an Independent Director as specified in the Act and the Listing Agreement and is independent of the management.

The Board considers that her continued association would be of immense benefit to the company and it is desirable to avail services of Mrs. Anita Jhunjhunwala as Director. 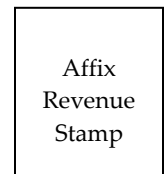
